#### Dear Parent/Carer,

Glen Huntly Primary School is looking forward to another great year of teaching and learning and would like to advise you of Glen Huntly Primary School's back to school student supplies and voluntary financial contributions for 2024.

Based on the feedback provided to and by the Office Admin, Principal, teachers, Leadership team and GHPS School Council about the level of dissatisfaction with Maxim as the school provider, the School Council has reviewed what we will offer in 2024. In consultation and newly acquired knowledge from from the Department of Education that COS is a preferred supplier, the school will be moving to COS as our supplier.

The option that best meets the needs of all stakeholders will be to have the school return to a previous system which will be that the school will **bulk order classroom consumables, materials and resources.** The costing of these student items has been included in the first section. Parents/carers will not need to do any independent ordering, purchasing or wait for deliveries. Our goal is to reduce the risk of students not having their supplies as of day 1. Teachers will distribute each student's resources at school in their classroom. Teachers will help with naming resources. We will require payment for these items.

**Other contributions:** Schools provide students with free instruction to fulfil the standard curriculum requirements and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that is through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Glen Huntly Primary School values all family contributions towards improving our teaching and learning environment through Parent Payment Contributions which are a key part of ensuring that our students have access to additional resources that will assisting in achieving optimal goals, and the best education and support for our students.

Some of the differences made by voluntary parent contributions within our school include:

- Support and enrich the school's learning and teaching program, including STEM items.
- Deliver a range of sporting equipment.
- Enhance digital learning, including preservation and purchase of new devices.
- Maintenance and upgrade of library and library resources.
- Grounds, building and playground equipment maintenance and upgrade.
- Maintenance of soft fall, and turf.
- Maintenance and replacement of air conditioners, purifiers in the classrooms.

### **ONE PAGE OVERVIEW**



### **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

# **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:



#### **Curriculum Contributions**

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

# Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

# Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



## **FINANCIAL HELP FOR FAMILIES**

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



#### **SCHOOL PROCESSES**

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
